3. The appointment of Mr. Zuzer Hatim Lucknowala (DIN: 00979509), Chief Executive Officer of the Company, as Chairman and Managing Director of the Company, subject to the approval of the members of the Company.
4. The Extraordinary General Meeting of the members of the Company shall be convened on Tuesday, February 01, 2022 at the Registered Office of the Company situated at 303-305, Simran Plaza, Near Hotel Regal Enclave, Khar West, Mumbai – 400 052, Maharashtra, India.
